Masterclass summary

Land issues are firmly embedded within the Sustainable Development Goals and the UN–Habitat III New Urban Agenda. Governing the relationship between land and people is at the heart of the SDG agenda. A right to property is recognised in Article 17 of the Universal Declaration of Human Rights (United Nations, 1948). With this in mind, Institutional innovation and participation by the land professions and private sector is important.

Many of today's global challenges, such as global warming, urbanisation, food, water and resource scarcity and social and economic inequality are intrinsically linked to land. Strengthening land rights is central to ending extreme poverty, fostering resilient societies and enabling efficient land markets to help provide infrastructure and services.

Secure land rights create a framework of multiple benefits, including food security and economic advancement by being able to use the land as investment security for loans. The purpose of the institution of Land, in all its facets of governance and professionalism, is to enable transparent, effective and efficient land & property markets, the SDGs are a framework for achieving this goal

This learning exchange is an interactive dialogue aiming to demonstrate, deliberate and articulate how private sector land professionals can actively interact with the SDG framework, the outputs will inform land professional's engagement and partnership building with multiple stakeholders including Donor agencies, government and civic society.

The learning exchange will set out to open this dialogue (with examples) on how we can actively interact with the SDG framework to promote awareness, learning and collaboration.
